Terms & Conditions for FPX joint promotion campaign with Lelong.my

ORGANISER

- 1. The Promotion is organised by PAYMENTS NETWORK MALAYSIA SDN. BHD. (Company No.836743-D) (formerly known as Malaysian Electronic Clearing Corporation Sdn Bhd) ("PayNet") and INTERBASE RESOURCES SDN BHD (Company No.465435-U) ("IRSB") (collectively referred to as "Organisers").
- 2.
