To be eligible for participation in the contest, participants must follow the contest's instructions.

Participants are required to read our Personal Data Protection Notice ("Notice") carefully before participating in the contest. By providing us with your data and submitting your entry, you have indicated your consent and agreement to the terms of our Notice, the terms of this Contest, and the process and disclosure of data under the Personal Data Protection Act 2010. CONTEST PERIOD:

This Contest will be held on BMMB's official Instagram account (@mybankmuamalat) from **1st November 2023 – 14th November 2023**.

ELIGIBILITY:

This Contest is open to all individuals aged 13 years and above. This excludes BMMB employees and their immediate family members (*parents, siblings, spouses and children*).

MECHANICS OF THE CONTEST:

The Contest mechanics are outlined as follows:

1) Follow and Like

Begin by following BMMB's official Instagram account @mybankmuamalat and click "like" on the Contest post.

2) Spot and Describe

Find the hidden Debit Card-i within the posted image (*different images for each week*). In the comment section, state the number of cards you spot and describe the best thing about the new BMMB Debit Card-i with only 5 words.

3) Tag and Hashtag

Along with your comment, include the hashtag **#BetterWithMuamalat** and tag three (3) friends (*all three (3) tagged friends must also follow @mybankmuamalat on Instagram to validate your entry*).

The Contest will have an **Airpod Max** as the **grand prize** along with **LEGO sets (1 x 2)** and **Shopping Vouchers (5 x 2)** for weekly draw prizes.

DRAW FOR WINNER SELECTION:
