

**"BUY 1 FREE 1" POP MEALS**  
**BANK MUAMALAT CREDIT CARD**  
**Terms & Conditions**

The following terms and conditions shall be applicable to "Buy 1 Free 1" Pop Meals ("Campaign").

1. This Campaign is organised by Bank Muamalat Malaysia Berhad (Company No.: 196501000376 (6175-W)) ("BMMB").
2. By participating in this Campaign, all eligible Bank Muamalat Credit Card Cardholders ("Cardholders") hereby expressly agree to be bound by these Terms & Conditions and the decisions made by BMMB.
3. The Campaign is open to all new and existing Bank Muamalat Credit Card ("Card") Cardholders within the Campaign Period.
4. The following individuals are **NOT ELIGIBLE** to participate in this Campaign:
  - a. Any Cardholder who had cancelled his/her Card during the Campaign Period; and
  - b. Cardholders whose accounts with BMMB which have been suspended, closed or who are in breach of their Agreement with BMMB.

7. Order must be placed via the Pop Meals App and is only available for dine-in and takeaway at all Pop Meals outlets with a promo code BMMB1F1.
8. The complimentary meal is capped at RM15.00.
9. The purchased meal and the complimentary meal must be redeemed in the same transaction.
10. The Campaign is limited to the first 200 redemption on a first-come first-served basis.
11. Each Cardholder is limited to one (1) redemption per day.
12. This Campaign is not applicable with any other ongoing promotions, discounts, vouchers, or membership privileges and not exchangeable or replaceable for cash.
13. Cardholders hereby agree and consent to his/her personal data being collected, processed and used by BMMB in accordance with the Personal Data Protection Act, 2010 and BMMB Privacy Notice, which may be viewed on [www.muamalat.com.my](http://www.muamalat.com.my) for the following purposes:

15. BMMB reserves the right to amend, shorten, cancel, suspend or terminate this Campaign or any part thereof with seven (7) calendar days' notice. Such notice may be published by BMMB via its' website [www.muamalat.com.my](http://www.muamalat.com.my). It shall be the responsibility of the eligible Cardholder to be informed or otherwise seek out any such notice(s) validly posted regularly.

For the avoidance of doubt, the amendment, shortening, cancellation, suspension or termination of this Campaign by BMMB shall not entitle the eligible Cardholder or any other persons whatsoever to any claim or compensation against BMMB for any losses or damages suffered or incurred as a direct or indirect result of such amendments, shortening, cancellation, suspension or termination unless such losses or damages are attributable by BMMB's gross negligence, fraud or wilful misconduct.

BMMB is entitled to, at its discretion, disqualify/ reject any eligible Cardholders who do not comply with the terms and conditions stated herein and/ or are found or suspected to be tampering with the Campaign and/ or its process or the operations of this Campaign. Tampering shall include fraudulent activities involving any act of deceit and/ or deception and/ or cheating with regards to the Campaign.

BMMB shall not be liable for any injury or loss of lives and valuable or any other loss or damage whatsoever or however suffered or sustained by any eligible Cardholder arising or resulting, directly or indirectly in whole or part, from their participation in this Campaign or from the prize or prizes won by them through the Campaign or as a result of any act of omission on the part of BMMB. 24. The Terms and Conditions are also subject to all prevailing provisions of the Islamic Financial Services Act 2013 (IFSA) and Anti-money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001 (AMLA).
25. All parties are expected to understand and comply with the Malaysian Anti-Corruption Commission Act 2009 (including any amendments thereof). The Bank reserves the right to report any actions or activities subjected of being criminal in nature to the police or other relevant authorities and include to terminate the transaction hereof.
26. The Terms and Conditions including the discretion rights and/or power given to any parties under this document shall be subject to Shariah principles.
