To be eligible for participation in the Contest, participants must follow the Contest instructions.

Please read our Personal Data Protection Notice ("Notice") before participating in this Contest. By participating in this Contest, Customers hereby agree and consent to their data being collected, processed and used by BMMB in accordance with the Personal Data Protection Act, 2010 and BMMB Privacy Notice, which may be viewed on [www.muamalat.com.my](http://www.muamalat.com.my) for:

- i. The purposes of this Contest; and
- ii. Marketing and promotional activities, that are strictly limited to this Contest only and shall not be used for any general marketing purposes. Any use and/or publication of details provided in connection with this Contest, including entries, interview materials, responses and related photographs, shall be solely for purposes directly related to this Contest.

Notwithstanding the above, Bank shall protect the personal data of Customers, and the Customers may further agree to co-operate and participate in all reasonable advertising and publicity activities of BMMB in relation to the Contest without any compensation and/or consideration.

**I. CONTEST PERIOD**

This Contest runs from 20 June 2026 to 17 July 2026 and is hosted exclusively on BMMB's official Instagram (@mybankmuamalat)

**II. ELIGIBILITY**

- This Contest is open to the public. BMMB employees/subsidiary and their immediate family members (spouse, children, parents and siblings) are not eligible to participate in this Contest.
- All entries must remain publicly accessible on the participant's social media account (Instagram) throughout the entire Contest period to be eligible for evaluation.

### III. MECHANICS OF THE CONTEST

The Contest mechanics are outlined as follows:

#### **How to Participate:**

1. **Follow** Bank Muamalat official Instagram account **@mybankmuamalat** and ATLAS by Bank Muamalat **@atlasmuamalat.my** and **like** this post.
2. **Watch** and like our Father's Day Video '*Suara Hati Ayah*'.
3. Participants must answer one (1) question related to the video in the comment section of the contest post: "*How many children does each father have in the video?*".
4. In conjunction with Father's Day, participants are required to share a message expressing their appreciation for their father in the comment section. (**maximum 20 words**)
5. **Tag 3 friends** you think should join the contest and make sure they are following Bank Muamalat official Instagram account **@mybankmuamalat** and ATLAS by Bank Muamalat **@atlasmuamalat.my**.
6. Participants are required to include the hashtags **#HariBapa** and **#PeraduanBankMuamalat**.

#### **Ineligibility:**

- Posts and Instagram accounts that are deleted, set to private, or otherwise inaccessible during the judging phase will be disqualified
